## **SUPPLEMENTAL AFFIDAVIT OF STEPHEN J. CIRAMI**

STEPHEN J. CIRAMI, being duly sworn, deposes and says:

1. I am a Senior Vice President of Operations for The Garden City Group, Inc. ("GCG") located at 1985 Marcus Avenue, Suite 200, Lake Success, New York 11042. Pursuant to the Court's December 15, 2011 Order Concerning Proposed Settlement with the Director and Officer Defendants ("Pretrial Order No. 27") and the Court's December 15, 2011 Order Concerning Proposed Settlement with the Settling Underwriter Defendants ("Pretrial Order No. 28") (collectively, the "Notice Orders"), GCG was appointed as the Claims Administrator in connection with the settlement reached with the director and officer defendants in the abovecaptioned action (the "D&O Settlement") and the settlements reached with the settling underwriter defendants in the above-captioned action (the "Underwriter Settlement" and,

together with the D&O Settlement, the "Settlements").<sup>1</sup> I submit this Affidavit as a supplement to my Affidavit dated March 8, 2012 that was attached as Exhibit 2 to the Joint Declaration of David Stickney and David Kessler filed with the Court on March 8, 2012. I have personal knowledge of the facts stated herein.

2. Pursuant to the notice program described in my prior affidavit, beginning on January 18, 2012, GCG commenced mailing of the Notice Packet to potential members of the Settlement Classes and the brokerage firms, banks, institutions and other third-party nominees ("Nominees") contained in GCG's Nominee Database. Paragraph 27 of the Notices required that within 14 days of receipt, Brokers and other Nominees who bought Lehman Securities as a nominee for a beneficial owner were to provide to GCG the names and addresses of such persons and entities or request copies of the documents to forward onto these beneficial owners. To the extent that GCG did not receive timely responses from the largest Nominees to which the Notice Packets were mailed, GCG followed up with these Nominees by making phone calls to ensure they received the Notice Packet, and, when someone for the Nominee could not be reached by telephone, GCG sent emails alerting the Nominee of the Notice Packet and GCG's attempts to reach them by phone. GCG fulfilled requests from Nominees to either mail Notice Packets to beneficial owners or provide Nominees with Notice Packets to forward onto the beneficial owners directly as such requests were received.

Through April 2, 2012, GCG has mailed a total of 902,602 copies of the Notice
 Packet to potential members of the Settlement Classes or their nominees.

4. As set forth in my prior affidavit, GCG is maintaining a website (www.lehmansecuritieslitigationsettlement.com) dedicated to the Settlements. On March 9, 2012, GCG posted copies of the papers filed in support of the final approval motion and the fee and expense application to the settlement website.<sup>2</sup>

5. As set forth in my prior affidavit, the Notices informed potential members of the Settlement Classes that written requests for exclusion from one or both of the Settlement Classes were to be sent, such that they were received no later than March 22, 2012, to *In re: Lehman Brothers Equity/Debt Securities Litigation*, c/o GCG, Claims Administrator, P.O. Box 9821, Dublin, OH 40317-5721. GCG has been monitoring all mail delivered to that Post Office Box.

6. As previously reported, as of March 6, 2012, GCG had received 10 requests for exclusion. As of the date of this Affidavit, GCG has received an additional 78 requests for exclusion. As a result, GCG has received requests for exclusion from or on behalf of 88 persons and entities. Specifically, 74 persons and entities have requested exclusion from the D&O Settlement Class, as set forth in Exhibit A, and 64 persons and entities have requested exclusion from the Underwriter Settlement Class, as set forth in Exhibit B.<sup>3</sup>
